THE BEGINNING OF ALCOHOLICS ANONYMOUS

One can start the history of AA in many places. For this piece, I will start with Roland Hazard and Carl Jung. Roland was a well-educated New England industrialist from a very successful family. He did have a big problem with drinking. About 1930 (the exact date has been debated by historians), he visited the celebrated Swiss psychiatrist, Dr. Carl Jung. After some treatment, Roland thought he would be OK but soon found himself drunk again. Returning to Dr. Jung for an answer, Dr. Jung informed him he was a chronic alcoholic and doomed, but in rare cases, people such as himself could have a vital spiritual experience, which would relieve his alcoholism. Roland returned to the United States and found help in the Oxford Group, a 20th-century Christian organization, which stressed "surrendering one's life over to God's plan."

The Oxford Group sought to help others. Roland became active in the Oxford Group, and helped an alcoholic by the name of Ebby Thatcher. In 1934, in Manchester, Vermont, Roland convinced a judge whom he personally knew to let him have a chance at helping Ebby instead of committing him to an institution or jail. Ebby traveled some with Roland, and then he deposited him at the Calvary Mission, the New York headquarters of the Oxford Group. Ebby was told the Groupers (as they called themselves) helped other people. When asked if he knew anybody that might need their help he thought of his Vermont friend, Bill Wilson who was now living in Brooklyn, a subway ride from where they were. Ebby went to visit Bill in November 1934, while Bill was on his last binge. Bill wrote about Ebby's visit, in the Big Book of Alcoholics Anonymous. Bill soon had his last drink on December 14, 1934, before checking into Towns Hospital in New York for the third and last time. Bill had a "white light experience" while detoxing and never drank again.

Ebby took Bill to the Oxford Group meetings in the winter of 1935, and Bill wanted very much to help other alcoholics. However, Bill was unsuccessful at finding someone to sober up. When on a business trip in Akron, Ohio he felt the urge to drink, and instead of drinking, reached out to another alcoholic in the Oxford chapter there. He was put in touch with Dr. Bob Smith, a fellow Vermonter. Bob was a bad alcoholic, 15 years older, and had been hospitalized 10 times for alcoholism. Bill told Bob his story, and Bob said that was the first time he ever heard anybody speak of alcoholism

the way Bill did. Dr. Bob had one more slip and got sober; to never drink again.

These two men had the realization if they were to remain sober they must carry the message of sobriety to other alcoholics. So started the journey of Alcoholics Anonymous: June 10, 1935.

TRADITIONS CHECKLIST from the AA Grapevine

Tradition Nine: AA, as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve.

- 2. Do I resist formal aspects of AA because I fear them as authoritative?
- 3. Am I mature enough to understand and use all elements of the AA program—even if no one makes me do so—with a sense of personal responsibility?
- 4. Do I exercise patience and humility in any AA job I take?
- 5. Am I aware of all those to whom I am responsible in any AA
- 6. Why doesn't every AA group need a constitution and bylaws?
- 7. Have I learned to step out of an AA job gracefully—and profit thereby—when the time comes?
- 8. What has rotation to do with anonymity? With humility?


